

## **Our Privacy Commitment to You**

RTPS is committed to keeping your personal information accurate, confidential, secure and private.

When you visit our website, contact us, participate in one of our programs or attend an event, we are committed to protecting your privacy rights and your personal information.

RTPS' privacy policy is based upon the 10 Privacy Principles contained within the Canadian Standards Association (CSA) Model Privacy Code for the Protection of Personal Information and reflects the requirements of applicable legislation including the Personal Information Protection and Electronic Documents Act (PIPEDA). These principles are outlined below.

This Privacy Policy describes the principles that RTPS will use to protect the privacy of your personal information in its possession. It addresses the reasons why such information is collected, how it is used, how it's confidentially protected and outlines your rights with respect to this information.

This privacy policy is applicable to our Members, Customers, Community Partners, Volunteers and Employees.

Personal information is defined as any factual or subjective information, recorded or not, about an identifiable individual. Examples are age, name, source of income, home addresses and telephone numbers. Personal information does not include the name, title, or business address or telephone number of an employee of an organization.

## **RTPS' Privacy Principles**

### **Accountability**

RTPS is responsible for the protection of your personal information collected through our office(s), program activities and website. RTPS Co-Founder, David Rourke, is designated as our Privacy Officer, and has overall responsibility for the protection of personal information and for RTPS' compliance with this Privacy Policy.

**RTPS Privacy Officer Responsibilities include:**

- Documentation of uses of personal information
- Training employees in correct practices
- Compliance monitoring
- Reporting and dispute resolution

**Identifying Purposes**

RTPS will provide a statement to explain the purpose(s) for the collection of your personal information wherever possible, before we ask you to disclose it.

We collect personal data only when you make use of or register for our programs and services, in order to better meet your program, service and information needs.

We also use and disclose data, which does not identify individuals, for statistical purposes to assess, develop and improve RTPS programs and services.

We also collect personal information in order to refer you to enhanced services, or to satisfy legal, government and regulatory obligations.

We do not sell personal information we collect.

We will not disclose your personal information to anyone else without your prior knowledge or consent, except when required by a government body or agency, or as permitted by law.

If you supply us with your contact information, you may hear from us about important information concerning the RTPS program or service for which you are registered.

Although infrequently, you may also hear from us about other RTPS programs and services that may interest and benefit you or we may ask you for feedback about the services you have already received as part of our quality assurance commitment. If you do not wish to receive such communications please call 1-877-742-9776.

**Using our Website**

You can access our website home page and browse our site without disclosing your personal data. Any personal information that site visitors voluntarily choose to provide is not shared with third parties unless stated otherwise. RTPS will ensure all personal information is secured and remains confidential.

**Use of Cookies**

A cookie is a small text file containing a unique identification number that is transferred from a website to the hard drive of your computer so that the website may identify separate visitors to the site and track users' activities on the website. A cookie will not let a website know any personally identifiable information about you, such as your real name and address.

RTPS uses cookies only to keep track of how many people visit our website and how frequently each page is visited. Each individual movement of any user cannot be tracked while on our website. Cookies are only used to track page popularity for statistical purposes and to improve the quality of the site and meet your needs. (For more information on cookies, please check your browser's settings.)

### **RTPS Google Analytics Policy**

RTPS.ca leverages data collection software (Google Analytics Advertising) in order to continuously improve the user experience of the website and targeting of online advertisements. Google Analytics Advertising's Remarketing and Advertising Reporting features are specifically enabled on all rtps.ca pages so that advertising content can be tailored directly to audiences for whom it is of greatest value and relevance.

Round Table Procurement Services (RTPS) does not identify users or facilitate the merging of personally identifiable information with non-personally identifiable information collected through any online advertising product or feature. RTPS does not attempt to disaggregate data that Google Analytics Advertising reports in aggregate nor does RTPS have any intention to do so in the future.

### **Links on our Website**

Because RTPS wants your website experience to be of meaningful value to you, our website also provides a number of links to third party sites. RTPS assumes no responsibility for the information practices of sites you are able to access through our site. We encourage you to review each site's privacy policy before disclosing any personally identifiable information.

### **Consent to Collection of Your Information**

The only personal information that RTPS collects is with your knowledge and consent.

You can choose not to disclose any personal information we may ask you to provide. However, a decision to withhold some personal information can result in our inability to provide you with our services.

Further, you can withdraw your consent to the collection, use or disclosure of your personal information at any time, subject to any legal requirements and reasonable notice.

### **Limiting Collection**

The amount and type of information that RTPS collects is limited only to that which is necessary to fulfill the purposes identified. RTPS will ask for the information it requires directly from the individual. Personal information will be collected using procedures which are fair, transparent and lawful.

You can choose to disclose as much or as little personal information as you are comfortable with. As noted in Principle 3, a decision to withhold some personal information can prevent us from providing you with our services.

### **Limiting Use, Disclosure and Retention**

RTPS will use your personal information only for the purposes for which it was collected. Your information will not be disclosed to third parties without your knowledge and consent, unless permitted or required by law.

Individuals will be asked to review and approve a consent form, or have the opportunity to opt out of sharing their information, before any personal information is released to third parties for the purpose of providing enhanced services or otherwise.

Your personal information will be retained only as long as necessary to fulfill the purposes for which it was collected, and in compliance with any laws surrounding information retention. If all identified purposes for the use of your personal information have been exhausted, we will destroy the information or render it unidentifiable.

### **Accuracy**

In order to ensure the reliable delivery of services and information, your personal information will be kept accurate, complete and up to date.

We assume that the information that you provide to us is accurate. If at any time your personal information changes, we hope to be informed of it immediately. If you contact us with a request, we will take appropriate steps to update or correct the personal information in our possession that you have previously provided to us.

### **Safeguards**

RTPS employs a number of safeguards to protect your personal information against loss or theft, as well as unauthorized access, disclosure, copying, use, or modification. Such safeguards include physical measures, for example locked filing cabinets, restricted access to offices, and limiting access on a “need to know” basis, and use of passwords and encryption.

Procedures for implementing these measures are communicated to all employees to ensure compliance with this principle.

### **Openness**

RTPS has readily available specific information about its policies relating to the management of personal information. Our Privacy Policy is available at all times on our website, [rtps.ca](http://rtps.ca) under the “Resources” section.

**Individual Access**

Upon request, we will inform you if we hold any personal information about you and provide you with access to this information. If we have any personal information about you, we will also tell you for what purposes it is used for, if applicable.

You have a right to update any personal information that we hold on you. Should you wish to see the full contents of your information that is on file, you must make a formal written request and mail or email it to:
